- ___ That I shall defend, save, and hold harmless the City, its elected and appointed officials, officers, employees, agents, contractors and volunteers from any and all claims, liabilities, causes of action, losses and damages that may, at any time, arise or be claimed by any person or entity as a result of bodily injury, sickness, death, or property damage, or as a result of any other claim or suit of any nature whatsoever allegedly arising out of, resulting from, or in any manner connected with or related to, directly or indirectly, the proposed or actual utilization of City property. In the event that any person or entity obtains a judgment or settlement against the City, I shall promptly indemnify the City in the amount of said judgment or settlement and for all costs and expenses related thereto, including, without limitation, reasonable attorney and expert witness fees.
