Executive Summary:

There are approximately 2700 fire hydrants in the City. The hydrants have not been sandblasted and repainted in fifteen years and most are in need of painting. The contract for the proposed work is for five years with an increase annually. At the end of the five years most hydrants would be repainted and the paint should last another fifteen years. The project is budgeted in this fiscal year and the following three years.

Bid was advertised with two companies responding. Giant Maintenance was the low bidder with a price of \$84.85 per hydrant. At this price approximately 500 hydrants would be repainted this year, weather permitting.
