#### 2025 Consolidated Election Packets Available on Friday, August 16, 2024

**ST. CHARLES, Ill.** (Aug. 14, 2024) – Nomination Packets for the 2025 Consolidated Election will be available starting on Friday, Aug. 16, 2024. Residents may pick up their packet at the Reception Desk in the St. Charles Municipal Building, 2 E. Main Street, from 8:00 a.m. – 4:30 p.m., Monday through Friday. If you prefer to have your packet emailed, please send your request to [msheets@stcharlesil.gov](mailto:msheets@stcharlesil.gov) and it will be sent by the next business day. **Petitions cannot be circulated for signature before August 20, 2024.**

The completed nomination packets must be filed between Nov. 12 and Nov. 18, 2024. All forms are due to the City Clerk's office, 2 E. Main Street, St. Charles, no later than 5:00 p.m. on Nov 18, 2024.

The 2025 Consolidated Election will be held on April 1, 2025. The following offices, which hold four-year terms, are up for election with one unexpired 2-year term.
