<p><b>Executive Summary</b> (if not budgeted, please explain):  Beginning July 2023, City staff began executing on the three-phase Public Engagement Platform project by configuring and implementing Phase I and select Phase II Granicus application components. The three phases of the project are:</p> <ul style="list-style-type: none"> <li>• Phase I: Replacement of City websites and initiation of digital forms and communications</li> <li>• Phase II: Digital public meeting management, and a citizen engagement application (similar to the one used for the Strategic Planning process)</li> <li>• Phase III: Digital public records request management</li> </ul> <p>In-progress and completed components include those utilizing govDelivery (public communication application), OpenForms (online form building application), OpenCities (website building application), and EngagementHQ (a community engagement site builder). Completed components are being published as they are finished. Remaining components of Phase I are expected to be completed in the second half of 2024. Remaining components of Phase II are expected to begin configuration and implementation in the second half of 2024.</p> <p>The initial software subscription for EngagementHQ and the first annual software subscription renewal for govDelivery, OpenCities, and OpenForms are now due.</p> <p>Staff is recommending approval of Granicus, LLC software subscriptions for OpenCities, OpenForms, EngagementHQ, and govDelivery in the amount of \$28,528.</p>
